GENERAL TERMS AND CONDITIONS OF CONTRACT

concluded by and between:

Hungarian Gas Trade Ltd. (seat: 1138 Budapest, Váci út 144-150.; tax number: 12543300-2-44; trade registry number: 01-10-045044, e-mail: gazkonferencia@mfgk.hu, operational licence number issued by the Hungarian Energy and Public Utility Regulatory Authority - 1054 Budapest, Bajcsy-Zsilinszky út 52. - with regard to natural gas trade activity: 238/2009), as the operator of the website accessible via www.gazkonferencia.info and www.gasconference.net (hereinafter referred to as: „Portal”) and the organizer (hereinafter referred to as „**Organizer**”) of the event published thereon (**49th International Gas Conference and Exhibition**, hereinafter referred to as „**Event**”)

and

every natural or legal person user completing registration via the Portal (hereinafter referred to as “**User**”).

Legal Basis for the Activity:

- Act No. V of 2013 on the Civil Code;
- Act No. CVIII of 2001 on Certain Aspects of Electronic Commerce Services and Services related to Information Society;
- Act No. CXII of 2011 on the Right of Informational Self-Determination and on Freedom of Information;
- Act No. CLV of 1997 on Consumer Protection;
- Act No. XLVIII of 2008 on the Basic Requirements and Certain Restrictions of Commercial Advertising Activity;
- Government Decree No. 15/2014 on the Detailed Rules of Contracts between Consumer and Company.

Objective of Portal

Following the submission of certain corporate and personal data on the Portal, Users can apply (register) for the **49th International Gas Conference and Exhibition**.

Event: 49th International Gas Conference and Exhibition

Date: November 7-8, 2017

Venue: Hotel Azúr, Siófok

Contractor performing technical organization: Young & Partners Ltd

Participation Fee, Exhibition Fee

The participation fee includes participation in the professional programmes of the Event on November 7-8, 2017, meals (coffee breaks, lunches, gala dinner), the conference package and participation in the evening programmes of November 7, 2017.

The participation fee does not include the costs of accommodation. Accommodation can be reserved via the Event website, but the costs of accommodation must be paid directly and individually at the selected hotel.

The Exhibition Fee is calculated by the unit prices of the chosen standard services; in case of an individual need the Exhibition Fee shall be pursuant to a specific agreement between the Parties.

Registration Procedure, Conclusion of Contract

Registration for the Event (as a participant or an exhibitor) is possible via the Event website (Registration/Online Registration) Registration is carried out by filling in the application form and by accepting the General Terms and Conditions of Contract (ÁSZF). By clicking on the Send button, User agrees to be bound by the provisions of the ÁSZF. User receives an automatically generated system message on the receipt of the registration by the Organizer, which shall not yet establish a contract between the Parties. The Contract is concluded by and between the Organizer and the User by the confirmation sent by the Organizer via email including a proforma invoice.

The electronic contract concluded by and between the Organizer and the User shall not be construed as a written contract, hence it shall not be filed and cannot be later accessed on paper.

User shall be responsible for the accuracy, veracity and completeness of the data submitted during registration. Organizer shall not be held responsible for any damage arising from incorrectly submitted data even if it could have detected such data inaccuracy.

Payment Conditions

Following registration, the Organizer sends a proforma invoice on the full amount of the participation and/or exhibition fee. Having received the advance payment, the Organizer sends the advance payment invoice to the User.

Upon closing the Event, the Organizer issues and dispatches the final invoice to the User.

The due date of participation and/or exhibition fee payment shall be the 15th (fifteenth) calendar day from the issue date of the proforma invoice/final invoice, but not later than the day preceding the Event date.

Payment shall in any case be carried out by transfer indicating the number of the proforma invoice or the given invoice in the comment field.

Participation in the Event shall be conditional on the payment of the participation and/or exhibition fee.

Modification, Cancellation of Registration

Modification of Event registration or cancellation of participation shall be sent to the Organizer in writing (by filling in the contact form available on the Event website, or by sending it to the email address confirming the successful registration).

Participation can be cancelled until October 6, 2017 free of charge.

In case of cancellations requested between October 6-20, 2017, the penalty for cancellation is 50% of the net participation and/or exhibition fee, which shall be deducted from the already paid and repayable participation and/or exhibition fee. The bank account number required for the refund transfer shall be submitted when cancelling the participation.

In case of cancellations requested following October 20, 2017, the Organizer cannot refund the participation and/or exhibition fee.

Failure to participate in the Event shall not provide exemption from the obligation to pay the participation and/or exhibition fee.

Cancellation of the Event

Provided that the Event is cancelled by the Organizer, the full amount of the participation and/or exhibition fee paid shall be refunded to the bank account given by the User.

Special Terms and Conditions of Exhibition

The venue of the exhibition shall be the hallway of Hotel Azúr.

The detailed terms and conditions applicable to the handover/takeover of rented stands and to the movement of exhibited objects during the Event shall be sent by the Organizer to the exhibition applicant Users until 27 October 2017.

Exhibition applicant Users shall understand that the Organizer's liability is limited to 50% of the exhibition fee in relation to the rent.

Exhibitor Users may not disturb the participants of the Event by their activity, and shall be fully responsible for any damage incurred during their activity throughout the Event.

It is the liability and responsibility of the Exhibitor Users to insure the exhibition objects.

Information on Data Protection

Having regard to Section 13/A, Subsections (1)-(3) of Act No. CVIII of 2001 on Certain Aspects of Electronic Commerce Services and Services related to Information Society – Organizer shall manage natural personal identification data and address disclosed by the User as personal data (hereinafter jointly referred to as personal data).

The purposes of personal data management shall be to establish the contract facilitating participation (hereinafter referred to as contract), determine the content thereof, monitor the performance thereof, invoice the fees arising therefrom and enforce any claims related thereto. In addition to personal data, data related to the date, duration and place of using the service are also managed by the Organizer for the purposes of invoicing fees arising from the contract. By application, User grants its consent to the Organizer to communicate key information related to the Event - if required.

In addition to the above, – for the purposes of providing the contractual service – Organizer may manage further personal data that are technically inevitable for service provision, with particular regard to the email address. Servers automatically register the User's IP address, the type of the operating system and browser programme used, along with certain other information upon entry in the Portal. The IP address and the log file may qualify as personal data in certain cases. Such information shall only be used by the Organizer in a manner not linkable to any person, in an aggregated and processed form, exclusively for the sake of correcting mistakes related to contractual service provision or for the purpose of improving service quality.

Any personal data managed shall neither be published nor transferred abroad by the Organizer. Organizer shall ensure data safety, and shall take any and all technical measures and establish procedural rules that are required for the implementation of data protection provisions. Personal data management commences upon application (by the User's clicking on the Send button), and Organizer shall immediately delete personal data following the conclusion of the contract is cancelled or the contract is terminated upon performance by both Parties.

User shall be entitled to the following rights and legal remedies in relation to data management:

a) User may request information on personal data management from the Organizer using its contact details (e-mail: info@mfgk.hu; postal address: 1398 Budapest Pf. 564., phone number: 354-7000); during which the Organizer provides information on the data it manages, on the purpose, legal basis and duration of data management, or on data processing, or on the legal basis and recipient of data transfer. [Sections 14-15 of Act No. CXII of 2011 on the Right of Informational Self-Determination and on Freedom of Information (hereinafter referred to as Info Act) Organizer shall provide such information in writing within 25 days, which may only be refused on grounds specified by law. In the event that the provision of information is refused, Applicant may resort to judicial

remedy to enforce its rights, or may request an investigation from the National Authority for Data Protection and Freedom of Information (hereinafter referred to as NAIH). (Section 16 of the Info Act)

b) User may request the correction, deletion or blocking of personal data at any time from the Organizer using the contact details specified in item a). Personal data are deleted, corrected or blocked – unless the request is refused by the Organizer – within 5 business days from receiving the request. Where the Organizer does not carry out the request for correction, blocking or deletion, the factual and legal reasons for the refusal shall be communicated to the User within 30 days. In the event that the request is refused, User may resort to judicial remedy to assert its rights, or may request an investigation from NAIH. (Section 18, Subsection (2) of the Info Act).

c) User may object to the management of their personal data in a statement submitted to the Organizer using the contact details specified in item a) if the lawfulness of data management is contested; in which case the Organizer shall inform the User with regard to the decision in writing. Insofar as Users disagree with the decision, they may refer the matter to court (court of justice) in order to assert their rights, in which case the court proceeds urgently. (Sections 21-22 of the Info Act)

Copyright

Content published on the Portal shall be the Organizer's intellectual property.

The use of any third party copyrighted content published by the Organizer (e.g.: quotes, photos, graphic contents, trademarks, logos, domain names etc.) shall in any case be subject to Act No. LXXXVI of 1999 on Copyright and Act No. XI of 1997 on the Protection of Trademarks and Geographical Indications. Any use beyond the above requires consent from the relevant author.

Miscellaneous

The official language of the Event is Hungarian. Organizer provides simultaneous interpretation into English for the professional programme of the Event.

Organizer reserves the right to modify the announced programme of the Event.

Organizer draws the attention of the User that video/audio recordings may be made or photos may be taken of the event. The Organizer may use such audio and video recordings in its printed and online materials and in the conference news reports.

Organizer reserves the right to amend this ÁSZF in part or in full at any time.

Organizer endeavors to provide authentic and accurate information, however, assumes no liability for any damage arising from information published on the Portal.
